17/01/2454 Story Homes Meeting

Cllr Jefferson and Cllr Slinger had an informal meeting with Story Homes on the 4th January to discuss their outline plans for the fields between Low Road, Forge Lane and Forgewood Drive. Story Homes explained that they have a plan to build 85 low-density homes. The Parish Council highlighted aspects that might be beneficial to the village, such as a football pitch, road crossing and route for B4RN. The Council also referred to the previous Local Plan, which indicated a need for smaller homes, such as 2 bed homes. Story Homes are planning to provide 30% affordable homes. There will be a public consultation on 17th January between 17:00-20:00 in The Centre.

17/01/2455 Membership of Environmental Law Foundation

The Environmental Law Foundation can provide free legal advice on environmental issues, especially in relation to developments.

It was resolved: that the Parish Council joins as a member of EFL at a cost of £60 pa.

17/01/2456 War Memorial bus stop bench

It was resolved: that a bench for the War Memorial bus stop will be purchased for £290.

17/01/2457 Review of Groundsmen Hours and Budget

The Parish Clerk reported that the budget for the Groundsmen has been exceeded by 42 hours, so no further progress can be expected on the various outstanding winter tasks unless the budget is increased. **It was resolved:** that an extra £1,500 be added to the Groundsmen budget for the rest of the year. **It was resolved:** that the Parish Clerk distributes the current job list.

It was resolved: that Envirocare will be contracted for all areas except St Wilfrid's Park at a cost of £1,800. Lancaster City Council be contracted to cut the grass on St Wilfrid's Park on a weekly basis at an estimated cost of £1,400.
